What is Cyberbullying?



WHAT CYBERBULLYING

willful and repeated bullying that takes place over digital devices like cell phones, computers, and tablets. Cyberbullying can occur through SMS, Text, and apps, or online in social media, forums, or gaming where people can view, participate in, or share content.

Cyberbullying definition derived from StopBullying.gov & Cyberbullying Research Center

Slander: Stating that the victim has committed something criminal or illicit in social networks and message groups;

Hacking: This may include hacking into the victim's social media account, with the aim of damaging their reputation or causing damage to their personal life.

Defamation: Post on social networks and message groups information that reaches the honor of the victim;

Injury: Opinions about anyone who is derogatory through social media;

Threat: Send messages, photos or videos

threatening the victim with aggression or

defamation;

10 Ways of Cyberbullying

Cyberstalking: This may include constant monitoring of the victim's online activity, including their social media accounts and other online activities.

Sexting: This may include sending explicit

sexual messages or images to the victim

with the intent to embarrass or humiliate.

Disturbance: Constant sending of derogatory messages constantly;

False identity: Create a fake profile of the victim or a profile to attack the victim;

Illegal Embarrassment: Threatening a person to do something they wouldn't want on social media;

Consequences of Cyberbullying – For Victim

- 6. Suicidal thoughts;
- 7. Revenge Thoughts;

Cyberbullying cases

Megan Meier

- The 13-year-old girl took her own life in October 2006, after being told by her "virtual boyfriend" Josh that the world would be better without her. The point is that Josh's profile was fake and was created by members of a neighborhood family, including a friend of Megan and her mother, who knew about the girl's emotional instability and wanted to take revenge for a conflict caused at school.
- The girl's parents created a<u>non-governmental entity to combat bullying</u> and cyberbullying worldwidewhich encourages research and does support work related to the problem.

Phoebe Prince

• O<u>suicide</u>by Phoebe Prince occurred inJanuary <u>14thin2010</u>. Prince, 15, hanged himself at his family home in South Hadley,<u>Massachusetts</u>, after being a victim of<u>cyberbullying</u>at the school where he studied. His death, which shocked the city, led to the creation, in the following May, of the Lawanti-bullyingof Massachusetts, at the time the most comprehensive in the country.

Hana Kimura

 A Japanese fighter who participated in a reality show, consequently being the target of<u>cyberbullying</u>for a long period, Hana made a series of suicidal posts on her social media and shortly after, she was found dead on May 23, 2020. The cause of death was determined to be suicide by intoxication.



Lucas Santos

The most recent fatal case of cyberbullying is • the teenager Lucas Santos, which occurred on August 3, 2021. Lucas was the son of the famous forró singer Walkyria Santos and took his own life at the age of 16. According to information passed on by the mother, Lucas could not stand the prejudiced jokes after a video of him and a friend made, according to the boy, "made to make waves". The mother spoke about the young man's death and said that his TikTok account was flooded with bigoted and extremely offensive comments. Lucas's concern, however, was what his aunt would think and that he might even get a severe beating.

— As crianças e os adolescentes aprendem rapidamente a usar as ferramentas disponíveis na internet. Só que eles não conseguem compreender que os mesmos valores e obrigações da vida real precisam ser aplicados na internet. E que eles também podem ser punidos pelo que fazem no mundo virtual. Os pais e educadores não estão conseguindo ensinar isso.

O "TOP 10" é um ranking que classifica dez meninas como "vadias". Os nomes circulam pelo WhatsApp, vídeos no Youtube e Facebook. Os estudantes pegam fotos das redes sociais para montagem ou se utilizam de imagens de nudez que as meninas mandaram para algum namorado que repassou para os colegas. As vítimas dessa brincadeira têm suas vidas devastadas e passam a enfrentar depressão, algumas abandonam a escola e até mesmo tentam tirar a própria vida. Os pais dos responsáveis por montar a lista, e até mesmo das vítimas, não tomam conhecimento do que se passa com os filhos. As vítimas se calam.

How to prevent cyberbullying?

Ways to report cyberbullying

- When there is no possibility of identifying the aggressor and/or there is no space to resolve it in a mediated and preventive way, the case can be communicated to the Tutelary Council, the Public Ministry or the police station when there are infractions, such as moral or physical aggression.
- It is important to record all offensive messages and images received and block contacts. The victim or legal guardian must file a police report with evidence - messages, photos, e-mail, cell phone number of the origin of the attacks, address of the pages, profiles and publications - so that investigations can begin. School, family and witnesses are co-responsible and may be held liable for omission if they neglect the signs and consequences of thecyberbullying.

- 7. Can talking to the abuser help you?






